This statement taken regarding the ARMED ROBBERY
of BROWN'S CHICKEN which occurred on JULY 24, 1985
at 11606 S. WESTERN AVE at 3:19 P.M.

I understand I have the right to remain silent and that anything I say can be used against me in a court of law. I understand that I have the right to talk to a lawyer and have him present with me during questioning, and if I cannot afford to hire a lawyer one will be appointed by the court to represent me before any questioning. ON JULY 24, 1985 I WAS AT 59TH AND WILCOTT AND
I WAS APPROACHED BY RIO HARPER AND MY STEP-SON
SHADEED SHARIF. THEY HAD A YOUNG GIRL WITH THEM
AND ASKED ME TO DRIVE THEM TO THE BROWN'S
CHICKEN ON WESTERN AVE. THEY SAID THEY WERE GOING
TO TRY TO GET SOME MONEY FROM THIS PLACE AND I
KNEW THEY HAD A ROBBERY IN MIND, THEY DIRECTED
ME TO THE BROWN'S CHICKEN AT 116TH AND WESTERN
AND WHEN WE GOT THERE I LET THE THREE OF THEM
OUT OF THE CAR AND DROVE AROUND THE BLOCK AND
PARKED. THE CAR I WAS DRIVING WAS A 1978 BUICK
LIMITED 2 DOOR LIGHT YELLOW IN COLOR. RIGHT
AFTER I PARKED THEY CAME RUNNING TO THE CAR,
